Desirable Educational Qualifications & Experience:
Doctorate in Physical/ Marine/ Chemical Oceanography/ Meteorology/ Atmospheric Sciences/ with research experience in any of the fields mentioned at point (ii) above and Experience with data analysis software (e.g., Ferret, GRADS, ODV etc) and programming languages (eg: Matlab, C, Fortran etc.).
Job Responsibilities :
The selected candidates will be required to contribute in oceanography data collection, data management, data analysis, development of ocean models, ocean data analysis, research leading to improvement of models performance, providing training on various capacity building activities.

## Period of deputation :

Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or Department of the Central Government, University, Research Institutions, Public Sector Undertaking, Semi-Government or Autonomous Organisations shall not exceed five years or attaining the age of superannuation (60 years) whichever is earlier.
