Applications in plain paper are invited from interested persons, who are otherwise not ineligible or disqualified as per the provisions of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and Members of the State Commission and District Commission) Rules, 2020, for appointment as Presidents and Members of the State Consumer Disputes Redressal Commission (State Commission) and District Consumer Disputes Redressal Commissions (District Commission) **on part-time basis** subject to their fulfillment of the eligibility criteria and submission of the application on or before **12:00 noon of 04.10.2021**.

1. Name of post : ***Member, State Consumer Disputes Redressal Commission***
No. of posts : ***3 (three), of which at least one member shall be a woman***
Eligibility : The applicant should be at least 40 years of age, with a bachelor's degree from a recognized university, preferably having special knowledge and professional experience of not less than twenty years in consumer affairs, law, public affairs, administration, economics, commerce, industry, finance, management, engineering, technology, public health or medicine.
Honorarium : Rs. 3,500 per day of sitting.
Other allowances: Rs. 500 per day of sitting.
2. Name of post : ***President, District Consumer Disputes Redressal Commission***
No. of posts : ***3 (three) (1 post each for Hnahthial, Khawzawl and Saitual district)***
Eligibility : Any person who is, or has been, or is qualified to be a District Judge.
Honorarium : Rs. 4,500 per day of sitting.
Other allowances: Rs. 500 per day of sitting.
3. Name of post : ***Member, District Consumer Disputes Redressal Commission***
No. of posts : ***10 (ten) (1 post each for Champhai, Kolasib, Lunglei and Siaha district, and 2 posts each for Hnahthial, Khawzawl and Saitual district, of which the post under Kolasib and 1 post each under Hnahthial, Khawzawl and Saitual are reserved for women).***
